Resolution 40/23: RCC consider the possibility of installing a change facility at the northern end of the beach.

## Council response:

Based on the request, it is assumed that the request relates to change rooms within Dunningham Reserve.

The construction of new toilets at the northern end of Dunningham Reserve has recently been completed following plans that commenced many years ago and were deferred due to community opposition. A key concern for the community was the size and scale of any building within Dunningham Reserve.

The new toilets were planned and constructed to minimize visual impact from height and footprint.

There are no plans to construct separate change facilities or to amend the new toilets.

Change rooms are available and located centrally along the length of the beach.
