Resolution 5/24b - Signage to be increased /enlarged to indicate that the that the upper promenade at Coogee Beach is pedestrian only and Council Rangers to patrol this activity.

## **Council response:**

Randwick City Council Rangers undertake daily proactive patrols of the Coogee upper and lower promenades in order to ensure compliance with local regulations under s632 of the Local Government Act 1993 as well as the Companion Animals Act 1998.

Ranger Services will liaise with councils Technical Services department regarding ensuring appropriate compliance with any new or upgraded regulatory signage in Coogee.

Please also note that under NSW Road Rule 250

#### 250 Riding on a footpath or shared path

- (1) The rider of a bicycle who is 16 years old or older must not ride on a footpath unless —
- (a) if the rider is an adult—the rider is accompanying a child under 16 years of age who is riding on the footpath and the child is under the rider's supervision, or
- (b) if the rider is not an adult—the rider is accompanying a child under 16 years of age who is riding on the footpath under the supervision of an adult and the rider is also under the supervision of the adult, or
- (c) the rider is a postal worker who is riding the bicycle in the course of his or her duties as a postal worker, or
- (d) the rider is carrying a person who is under 10 years old as a passenger on the bicycle or in or on a bicycle trailer towed by the bicycle and the bicycle is not a pedicab.

Maximum penalty—20 penalty units.

#### **Resolution:**

Resolution 6/24 - Council to consider options for preventing high traffic areas, such as the pathway from Beach St to Dunningham Reserve, and other areas (e.g area adjacent to Coogee Amenities block) becoming "dirt bowls".

## **Council Response:**

I wish to inform you that Council is about to initiate a project at Goldstein Reserve as part of Councils 2023/24 capital works program. Programmed works to be undertaken after Anzac Day and will commence early May. Works will be broken into sections of work face- sequenced as such- Trees/ Paving/ Stormwater/ Showers/ Bike racks turf.

#### Scope includes.

- o Tree surrounds on Arden St x8-10 will be treated with porous paving.
- Locate stormwater main near amenities building and install 600mmx 600mm stormwater gate to minimise ponding/ blocking.
- Returf of all bare areas (extent 800m2)
- Relocate bike racks and install new bike racks between café and large mosaic (6x new bike racks)
- o Mulching over tree roots of Norfolk Pine between café and mosaic
- o Install 2x new showers northern end of promenade.
