- **8.5** Advertising on Coogee Oval . Response from Resolution 7/23 was discussed. The temporary advertising screening which assists in crowd control appears to remain in place for the whole season thus blocking the view of a lovely green space to people walking by. Resolution 19/23 .RCC to be requested to remove the temporary advertising screening when there is a gap > 1 week between the sporting club's home matches/games .
- 8.6 Dunningham Reserve Toilet Block. The Precinct was disappointed that earlier Resolution 22/22 was not supported by Council. Discussion followed that all new amenities everywhere now seem to be constructed to be (understandably) "vandal proof". Resolution 20/23. Hand drying facilities (preferably electrical) be provided at the toilet block and hooks be placed on the back of doors to allow for hanging towels or clothes to prevent them becoming wet if they have to be placed on ground.
  8.7 Speed limit of bicycles on shared pathways. Response to Resolution 8/23 was noted. The fact that the promenade has heavy pedestrian traffic and an increased number of e bikes and scooters raises concerns.

  Resolution 21/23. Coogee Precinct requests that RCC investigates the possibility of imposing a 10Km/ hr speed limit on Coogee Promenade.
  8.8 Bundock Street Housing Redevelopment. It is hoped a representative of the Randwick Barracks Community Consultation Committee will attend the June meeting.
